In order to reduce the dropout ratio and encourage the Backward Class Students to undergo Post-Matric Courses, Government of India has introduced a scheme known as the Government of India Post-Matric Scholarship

Benefits:

- For SC- Under this scheme the eligible Scheduled Caste including NavBuddha students are paid maintenance allowance ranging from Rs. 230 p.m. to Rs. 550 p.m. for boys and girls (day scholar) Rs. 380 p.m. to Rs. 1200 p.m. for boys and girls (Hostellers).
- scholar and Rs. 150 to Rs. 425 per month for Hostellers

Eligibility:

- For SC- The parents/Guardian annual income up to Rs. 2.00 Lakh limit for full scholarship
- Student should be resident of Maharashtra
- First two children from family are eligible (SC category is exempted)
- Minimum 75% Attendance
- Renewal Policy: Students should have passed the previous year's examination.

- For OBC, SBC, VJNT - Maintenance allowance of Rs. 90 to Rs. 190 Per Month for day

Eligibility:

- Student should be resident of Maharashtra
- Candidate must be admitted through CAP [Centralized Admission process] of State CET Cell of Maharashtra State
- First two children from family are eligible
- Minimum 75% Attendance
- Renewal Policy: The student has to pass the previous year examination
- For OBC, SBC, VJNT-The parents/Guardians annual income should not exceed Rs. 1.00 lakh.
- For OBC, SBC, VJNT-parents income limit is in between 1.00 lakh to 8.00 Lakh
